Notification

As per GO (Rt) No 305/2023/H&FWD, dated 08/02/2023, Government has issued specific guidelines for the posting of Foreign Medical Graduates in Government Medical Colleges of the State for completing their internship in accordance with the norms issued by the NMC. Accordingly as per this office notification dated 13.02.23, online applications were invited from qualified candidates for the allotment of seats for completing the internship as stipulated by NMC & KSMC.

On scrutiny, it is found that, wrong category was selected by a lot of candidates instead of their original one and also wrong entries were made in case of KSMC provisional registration certificate validity. Also, this office was received so much requests from candidates, requesting to extend the cutoff date of online application for seat allotment. Due to the aforesaid matters, detailed certificate verification of the candidates is found necessary for pursuing further in the matter.

Accordingly, it is decided to **conduct a physical verification of the valid original certificates of the candidates** such as KSMC provisional registration, FMG Certificate, etc and the process of seat allotment will be done as a **Centralized Counseling Process** abiding to the conditions stipulated in the Government Order read above. The candidates who had applied as per the notification dated 13.02.23 are directed to strictly participate in the **Centralized Counseling process scheduled to be conducted on 8th & 9th of March 2023 at COK Auditorium, Medical College Campus** (Opposite to

Thiruvananthapuram Medical College Principal Office) as per the following schedule for the allotment of seats.

After the Centralized Counseling Process, ie on 09/03/2023, MOP UP counseling will be conducted and the candidate who cannot apply as per the notification dated 13.02.23, can only participate in the MOP UP counseling as per the below schedule. The seat allotment to candidates participating in the MOP-UP counseling will be strictly as per the availability of seats and also in par with the conditions stipulated in the Government Order.

The candidates participating in the allotment process are directed to produce all the **valid original certificates** such as Identity Proof, Degree Certificate, KSMC provisional registration, FMG Certificate etc for verification. **Seat allotment will be purely based on the decisions of the allotment committee** by considering the options earlier submitted by the candidates. If there are **no available seats in the choice submitted** by the candidates, the **committee will have the discretion for posting them in any institution.** At the time of verification, if it is found that **a candidate is to be posted under a category different from the one he/she applied** for then the applicant

should attend the schedule of that allotment.

Time schedule mentioned in the aforesaid table has to be strictly adhered too. **Late reporting will not be entertained under any circumstances.** The category wise list of candidates based on the online application is published herewith.
