As per Pay Revision order 2019 read as 1st paper above, 25% of total number of Senior Superintendents/ Lay Secretary & Treasurers are eligible for ratio/percentage based Higher Grade in the Scale of Pay of Rs. 56500-118100.

Total number of posts in the cadre of Senior Superintendent under this department is 48. Hence twelve senior most Senior Superintendents are eligible for ratio/percentage based Higher Grade at a given time. As per order read as 3rd paper above, three Senior Superintendents, who were granted ratio/ percentage based Higher Grade have been promoted to the cadre of Administrative Assistant. Accordingly, as per the order read as 1st paper above, three Senior Superintendents are eligible for Higher grade.

No(s) 11684/2019 ordered to maintain the status quo, in so far as seniority of the respective parties until further orders.
