Dr.George Philip, Assistant Professor, Government Dental College, Kottayam, as per his representation 6th read above, has informed that, his name is not included in the provisional seniority list and requested to include him in the seniority list.

The matter has been verified with the records and found correct. Being a regular

Assistant professor, and having post graduate Degree, he is placed in the first position in the seniority list.

Dr.George Skariah, Assistant Professor, Government Dental College, Thiruvananthapuram, Dr.Antony P G, Assistant Professor, Government Dental College, Kottayam, Dr.Ayyappan.K, Assistant Professor, Government Medical College, Manjeri, Dr.Ravindran.V, Assistant Professor, Government Dental College, Kozhikode and Dr.Seeja P, Assistant Professor, Government Dental College, Thrissur, as per their representations 7th to 9th and 11th to 12th read above, respectively, have requested to assign their seniority based on the PSC advice and the period of service.

These complaints have been scrutinised with the records in this office and Government directions received in this regard and it is found that,

As per the letter read as 1st paper above, Government have issued clarification in this regard as follows;

In this circumstances, the complaints 7th to 9th and 11th to 12th read above, will not stand and considerable as per the rules in force. Hence, rejected.

Dr.Ayyappan.K, Assistant Professor, Government Medical College, Manjeri, as per the representation 9th read above, has also informed that, he and Dr.Jayakumar. N had done Post Graduation under Lecturer quota in the year 2002. He has done Post Graduation at Calicut University and Dr.Jayakumar. N has done Post Graduation at Kerala University. Because of the late publication of result by the Calicut University, the date of acquiring Post Graduate Degree and hence the seniority is affected. Therefore, Dr.Ayyappan.K has requested to consider this matter and to allow seniority above Dr.Jayakumar.N.

Dr.Shiney Dominic, Assistant Professor, Government Dental College, Thrissur, as per the representation 13th read above, has also informed that, she and Dr.Iqbal.V.M, had done Post Graduation at the same time. She has done Post Graduation at Kerala University and Dr.Iqbal.V.M has done Post Graduation at Calicut University. Because of the late result publication by the Kerala University, the date of acquiring Post Graduation and hence the seniority is affected. Therefore, Dr.Shiney Dominic has requested to consider this matter and to allow seniority above Dr.Iqbal.V.M .

The above complaints have been scrutinised with the records in this office and Government directions received in this regard and it is found that,

As per the letter read as 1st paper above, Government have issued clarification in this regard as follows;

In this circumstances, the complaints 9th and 13th above, will not stand and considerable as per the rules in force. Hence, rejected.

Dr.Ravindran.V, Assistant Professor, Government Dental College, Kozhikode, Dr. David Tharakan, Assistant Professor, Government Dental College, Kozhikode and Dr.Shiney Dominic, Assistant Professor, Government Dental College, Thrissur, as per their representation read as 11th, 13th, and 17th above, respectively, have requested to check the date of acquiring Post Graduate Degree of Dr.Bindudas.R.

This has been verified with the records kept in this office and found that, the date of acquiring Post Graduate Degree and redesignation as Assistant Professor of Dr.Bindudas.R, is on 29.07.2012. Therefore, her date of acquiring PG Degree is corrected as 29.07.2012 and she is placed in the seniority list between Dr.Abhilash.B and Dr.Jayalekshmi.P.S.

Dr. David Tharakan, Assistant Professor, Government Dental College, Kozhikode, as per his representation 17th read above, has requested to check the date of acquiring Post Graduate Degree of Dr.Ravindran.V, Dr.Iqbal.V.M and Dr.Shiney Dominic and the date of joining of Dr. Dean C Pearl. He has also, informed that, he was worked as Lecturer on contract basis from 17.11.2007 to 13.02.2008 and requested to rearrange the seniority based on the date of completion of Post Graduation.

This has been verified with the records kept in this office and found that, the date of completion of Post Graduation of Dr.Ravindran.V, Dr.Iqbal.V.M and Dr.Shiney Dominic and the date of joining of Dr.Dean C Pearl, noted in the provisional seniority list are found correct.

The period worked on contract basis will not be considered for seniority. Therefore, These requests put forward by Dr.David Tharakan are not considerable as per the rules in force. Hence, rejected.

Dr.Shalini Krishnan.P, Assistant Professor, Government Medial College, Wayanad, as per her representation 10th read above, has requested to include the order of declaration of her probation in the seniority list.

This has been verified and included.

Dr.Abhilash.B, Assistant Professor, Government Dental College, Thiruvananthapuram, as per his representations read as 15th above, has informed that, Dr.Shalini Krishnan P had availed leave without allowances and hence her seniority may be checked.

This has been verified and found that, she was availed leave without allowances after declaration of her probation. In the Rule 10 (ab) of KS &SSR it is stated that;

"Where the special rules or recruitment rules for a post in any service prescribe qualification of experience, it shall, unless otherwise specified, be one gained by persons on temporary or regular appointment in capacities other than paid or unpaid apprentices, trainees and casual laborers in Central or State Government services or in public sector undertaking or Registered private sector undertaking, after acquiring the basic

qualification prescribed for the post".

As per the letter read as 2nd paper above, Government have issued clarification in this regard as follows;

As such, the eligibility and required service for promotion to the cadre of Associate Professor as per Rule 10 (ab) of KS &SSR will be calculated while preparing the DPC Note, on the occurrence of vacancy in the cadre of Associate Professor.

In this circumstances, the complaint 15th read above will not stand and considerable as per the rules in force. Hence, rejected.

Dr.Syed Khaja Hussain, Assistant Professor, Government Dental College, Thrissur, as per his representation 5th read above, has requested to correct his advice date and seniority.

This has been verified with the records kept in this office and found that, he was advised by the Kerala PSC as per advice no. RIA(2)179/08/GW; Dated: 04.05.2012 and joined duty on 28.05.2012. Later, he was discharged from service for want of vacancy, as per this office letter no. G4/9246/12/DME; dated: 13.06.2012 and the order no. E2/2350/12/DCC; Dated:18.06.2012 of the Principal, Government Dental College, Kozhikode. Later, he has been advised as per advice no. RIA(2)179/08/GW; Dated: 12.12.2013 and joined duty on 10.02.2014. He was discharged from service for want of vacancy not any fault of him. Therefore, he has the right to claim the seniority based on his first advice.

Therefore, the request is found correct and his seniority is fixed based on his first advice. Thus, his name is placed in the seniority list between Dr.Abhilash.B and Dr.Jayalekshmi.P.S.

Dr.Sarath.S.S, Assistant Professor, Government Dental College, Thiruvananthpuram, as per his representation, read as 16th above, has requested that, he and Dr.Fasalulla. O were advised by the Kerala PSC in the same advice and Dr.Fasalulla. O had the advice seniority. But, Dr.fasalulla.O has joined duty after three months from his joining date. Therefore, he has requested to place him before Dr.Fasalulla.O.

The matter has been verified. Dr.Sarath.S.S and Dr.Fasalulla.O has been advised through Kerala PSC in the same advice and Dr.Fasalulla.O had the advice seniority. But, after receiving advice, there was stay order dated: 30.11.2017, from the Hon'ble Kerala Administrative Tribunal in OA(EKM) 2799/2017. Soon after the stay period, he has been granted appointment, subject to the Final order in OA(EKM) 2799/2017. Later, as per the final order dated: 07.03.2018, of the Hon'ble Kerala Administrative Tribunal in OA(EKM) 2799/2017, his advice has been ratified. Therefore, Dr.Fasalulla.O will not lose his seniority, and the seniority of the doctor fixed in the provisional list is found correct.

Therefore, the representation 16th read above is rejected.

Dr.Sandeep Rajan, Assistant Professor, Government Dental College, Alappuzha, as per his representation 14th read above, has requested to correct his date of PSC advice.

This has been verified and hereby corrected.

The order of declaration of probation of Dr.Fasalulla.O, Dr.Sarath.S.S, Dr.Ajithkumar, Dr.Kurumba Prakash, and Dr.Sandeep Rajan, in the cadre of Assistant professor were not included in the provisional seniority list, which are hereby entered.
