The Principal of each college will prepare a list of candidates appearing from their college in the serial order of Reg.No. of candidates and send it to the Chairman in the new application form along with filled hall ticket and chalan receipt. Principals are requested to obtain application form and hall ticket from the office of the Directorate of Medical Education, Thiruvananthapuram.
