## **Notification**

The second round allotment process of the PG Medical (MD/MS/Diploma) Courses 2012 is scheduled to be held from 29.05.2012 to 30.05.2012 in the Directorate of Medical Education, situated in the Thiruvananthapuram Medical College campus. <u>The allotment for candidates other than service quota will be based on the rank list, published by the Commissioner for Entrance Examinations (CEE)</u>

Candidates wishing to attend the counseling will have to download the prescribed format of preference form from the website <u>"www.dme.kerala.gov.in"</u>. Candidates are required to fill in the college and course, which they would like to opt, in the preference form at the time of allotment.

Candidates can opt only for that course/college to which vacancy exists at the time of counseling. <u>Candidates those who had not attended the 1<sup>st</sup> round counseling, and those who had not joined in the allotted college and those who have discontinued the course after joining will not be considered for the second round allotment. Candidates who wish to continue the already allotted course need not attend the second round counseling.</u>

Selection will be based on the rank secured in the entrance examination and availability of seats. If a candidate is not able to attend the allotment process on genuine grounds, the parent/guardian, or any authorised person can act as proxy at the risk of the candidate. Such authorised person should produce an authorisation letter as mentioned in the Prospectus. Candidates have to produce the admit card of the entrance examination and the original certificates as mentioned in the Prospectus. Those candidates who had taken admission under All India Quota are required to produce the receipt to prove that the original documents are submitted before the Principals concerned. Those candidates who have taken admission under state quota and then vacated to join AIQ <u>will not be</u> considered for subsequent state counseling. Candidates who get selection in the counseling are required to report before the Principals of the concerned college <u>on 31/05/2012</u>.
