ORDER

As per the Government Order read as 3<sup>rd</sup> paper above, Government have issued orders revising the scales of pay of the teaching staff of Government Medical, Dental, Nursing and Pharmaceutical Science Colleges in the State w.e.f. 01.01.2006 in super session of Government orders read as Ist and IInd above . But a mistake has occurred inadvetantly in paragraph 24 of Annexure I of the Government Order read as 3<sup>rd</sup> paper above. Hence the paragraph 24 of Annexure I of G.O.(P) 425/2009/H&FWD dated, 14.12.2009 is modified as follows:-

**Date of Effect:** The date of effect shall be 01.01.2006. Revision from 01.01.2006 to 31.12.2006 shall be notional. Arrears from 01.01.2007 to 31.08.2009 shall be credited to the GPF Account and the amount will be permitted to be withdrawn only after 31.12.2012. All Allowances (except Non Practicing Allowance) shall be granted with effect from 10.09.2009. Non Practicing allowance shall be payable from the date of effect of ban on private practice, that is, 01/10/2009.

Similarly the date shown in paragraph 6 and paragraph 13.5 (ii) to Annexure II to G.O.(P)425/2009/H&FWD dated, 14.12.2009 shall read as August 31,2009 in lieu of November 30,2009. Also in paragraph 8 of Annexure II the month shown shall read as September 2009 in lieu of November 2009.

The GO (P) 425/2009/H&FWD dated 14.12.2009 is modified to the above extent.
