ORDER NO.J3/22270/2014/DME Dated.23/01/2015

1. The senior most Staff Nurses Grade-I who are eligible for promotion as per the rank in the Final Seniority List of Staff Nurses Grade-I published vide order read as 1st paper above, are hereby promoted as Head Nurses, in the scale of pay of Rs.16180-29180 as per rule 28(b)(ii)of KS&SSR and appended to this order. On promotion as Head Nurse, they are posted to the stations mentioned against each.
2. The promotion in respect of Smt.Bindu.K.B*. Smt.T.C.Sunila**,and Smt. Ashalatha.R.P*** Rank No 332,342 and 343 respectively, will be effected subject to the Hearing and Final Orders against the notice issued by the DHS vide Letter No.ES3/31477/2014/DHS Dated.02/11/2014.
3. The promotion of Smt.Aleyamma.K.V,Smt.Sajitha.K.C,and Smt.Sheeba.T.C.(Rank No.346,347 and 348) the junior most Staff Nurse Gr-I will also be subject to reversion according to the final orders of The Director of Health Service in the notice issued vide Letter No.ES3/31477/2014/DHS Dated.02/11/2014
4. Rank.No.88A.Smt.Pushpalatha.V.K and Rank No.200 Smt.Francina Antony are notionally promoted with retrospective effect from 30/12/2011 and 13/11/2013 respectively, the date of their immediate junior promoted as Head Nurse. The monitory benefits will be applicable only as per the general rules and orders of government regarding promotion with retrospective effect.
5. The Head of institutions concerned should verify the rank number and date of birth of the incumbents and satisfy themselves on the genuineness of promotion before they are relieved to join in the promoted post. Any discrepancy noticed should be reported to this office immediately.

6. In the case of Staff Nurse Grade-I who are not in service/LWA etc, but promoted as per this order will be null and void and report such instances to this office for further action.

7. This order is issued subject to the result of various writ petitions/OA pending in Honorable High Court/Kerala Administrative Tribunal in regard to seniority of Staff Nurse Grade-I, and reassignment/deletion of seniority by the Director of Health Services, and will be reviewed if found necessary.

8. The promoted as above will be placed on probation for a period of one year duty within a continuous period of two years from the date of joining of duty.

9. The date of relief/joining duty should be reported promptly.
