**DENTAL-MDS DEGREE COURSES, KERALA - 2014
THIRD & EXTENDED ROUND OF COUNSELLING**

The third round of Counselling to fill up the 50% State Quota seats under Self Financing Dental Colleges will be conducted on 30.06.2014 (Monday) at 10.00 am in the Office of the Director of Medical Education inside the Medical College campus, Thiruvananthapuram. The counselling will be manual and subject to the conditions and stipulations specified in the Govt MDS Prospectus for 2014 vide GO (Rt)No. 728/2014/H&FWD dated, 03.03.2014. The Counselling in respect of vacant State quota seats and AIQ seats will be notified separately in compliance of the directions of the Hon'ble Supreme Court in IA No. 15/2014 in Writ Petition No 433/2013 in Dr Fraz Naseem & Ors Vs Union of India & Ors dated 18.6.2014 and the counselling schedule published in the MCC website on 24.6.2014.

Candidates are advised to be familiar with Clause.XI, XII & XIII of the Prospectus. The Counselling to the General Quota seats will be based on the various merit and category lists published by the Commissioner for Entrance Examinations. The candidates are directed to report at the venue of the personal counselling before 9.30.am on 30.06.2014. The candidates appearing for the Counselling shall produce all their original certificates to prove their academic eligibility along with the Admit Card/Hall Ticket issued by the Commissioner for Entrance Examinations as stipulated in Clause.XI.7.

The details of seats available, specialty wise including reservations for the Counselling and the list of Participating Self Financing Dental Colleges, as approved by Govt vide G.O.(Rt).1992/2014/H&FWD dated 17.6.2014 & G.O.(Rt) No.2152/2014/H&FWD dated 28.6.2014 is available on the website of DME. Seats available at the time of allotment will be duly displayed and the candidate should submit his/her choice of College and Specialty in the Choice form in writing. The seats will be duly filled up then and there itself according to merit and eligibility. One Seat in OMFS-SC category in PMS Dental College that was kept unfilled pending disposal of W.P.14684/2014 is now released. Candidates who have already taken admission in a SFDC have to produce no objection certificate from the college to participate in this counselling.

The candidates who get allotment will be issued with an allotment memo. For 2014, Govt has notified that the Annual fee shall be Rs.5,00,000.00 (Rupees five lakhs only) This amount of fee should be paid in the college to which admitted. The last date of joining will be 30.6.2014, 5.00.pm

Important: The candidates who are allotted with a subject in the Counselling and who discontinues the course on any reason after the Centralised Allotment Process (CAP) shall be liable to pay the liquidated damages as per Clause 13-2 of the prospectus.
