As per this office order read as 1st paper above, the seniority list of Nursing Officer as on 31.12.2018 under Medical Education Service has been finalised. As per the orders read as 2nd and 3rd above the ratio of Nursing Officer and Nursing Officer Grade I is fixed as 1 : 1. On the basis of the seniority list published vide order read as 1st above, 58 senior most Nursing Officers are promoted to the cadre of Nursing Officer Grade I with effect from the dates noted against their names in the scale of pay governed in the respective pay revision orders read as 2nd and 3rd above. The list is appended to this order as Annexure I. On Promotion the incumbents are permitted to continue in the present station since the post of Nursing Officer and Nursing Officer Grade I are interchangeable.

The Principals of Medical Colleges are directed to communicate the copy of this order to all the Head of Institutions under their administrative control. The Principal concerned should confirm that the promotees in the list are informed properly in time.

The Head of Institution / Custodian of service records in respect of the incumbents should verify the date of birth, date of commencement of service and rank position with the seniority list of Nursing Officer and satisfy themselves about genuineness of the promotions if any. Any discrepancies noted should be reported to this office with connected details without fail. In such cases the promotions will be reviewed/ modified if required. Necessary entries regarding the promotions in respect of incumbents should be entered in the Service Book with proper authentication.

The arrears of pay and allowances will be governed as per order read as 4th paper above.
