Medical College, Thiruvananthapuram, as per representation read as 2nd paper above, he has informed that, his date of entry in Medical Education Service is 04.12.1996 and he took leave for study purpose to complete post graduate course. He has rejoined in service in the post of Lecturer in Pharmacy in the FN of 03.08.1998; and the date of joining in the cadre of Associate Professor at Govt. Medical College, Kozhikode is on 11.07.2013 FN not on 03.07.2013. He has also informed that his probation in the cadre of Associate Professor has been declared with effect from 20-03-2014 FN as per G.O (Rt)No.635/2019/H&FWD dated.11-03-2019.

The matter has been verified with the records and registers kept in this office, and found that he had joined on 04.12.1996 and took Leave Without Allowance for study purpose from 06-12-1996 to 02-08-1998 and he rejoined in service in the FN of 03.08.1998. Therefore, as per general rule 27 (c) of KS & SSR part II, he should be considered as a new entrant in service with effect from the date of rejoining in service ie, on 03.08.1998 FN. Hence the date of joining noted in the seniority list will stand as 03.08.1998 FN. His date of joining in the cadre of Associate Professor noted in the Provisional seniority list as '03-07-2013 AN' is corrected as '11.07.2013 FN'; and the date of declaration of probation is entered as '20-03-2014 FN'.

The date of declaration of probation of Dr. Haripriya.M (Sl.No.5) is entered as '14-03-2015'.
