**DENTAL-MDS- DEGREE COURSES, KERALA - 2014
THIRD & EXTENDED ROUND OF COUNSELLING**

The third round of Counselling to fill up the vacant State Quota seats and seats that have reverted to the State from AIQ as on 4.7.2014, 5.30.pm, will be conducted on 08.07.2014 (Tuesday) at 10.00 am in the Office of the Director of Medical Education inside the Medical College campus, Thiruvananthapuram. The counselling will be manual and subject to the conditions and stipulations specified in the Govt MDS Prospectus for 2014 vide GO (Rt)No. 728/2014/H&FWD dated, 03.03.2014. This is in compliance of the directions of the Hon'ble Supreme Court in IA No. 15/2014 in Writ Petition No 433/2013 in Dr Fraz Naseem & Ors Vs Union of India & Ors dated 18.6.2014 and the counselling schedule published in the MCC website on 24.6.2014.

Candidates are advised to be familiar with Clause.XI, XII & XIII of the Prospectus. The Counselling to the State seats will be based on the various merit and category lists published by the Commissioner for Entrance Examinations. The candidates are directed to report at the venue of the personal counselling before 9.30.am on 08.07.2014. The candidates, already admitted to any of the three Govt Dental Colleges in Kerala, and appearing for the Counselling, need only produce a letter from the Principal, indicating their admission status & proof of payment of the prescribed fees. All other attending the Counselling shall produce all their original certificates to prove their academic eligibility along with the Admit Card/Hall Ticket issued by the Commissioner for Entrance Examinations as stipulated in Clause.XI.7.

The details of vacant seats available, specialty wise including reservations and available for the Counselling is appended alongside this notification on the website of DME. Seats available at the time of allotment will be duly displayed and the candidate should submit his/her choice of College and Specialty in the Choice form, and relinquishment of the seat held in writing. The seats will be duly filled up then and there itself according to merit and eligibility.

One Seat in OMFS-SC category, at GDC, Kottayam, that was earlier surrendered to AIQ earlier, reverted to the State by GOI and which was given Dr.K.E.Raneesh, the Petitioner W.P.14684/2014 is deemed to be a reverted SC seat. Candidates who have already taken admission in a SFDC's will not be permitted to participate in this counselling as the last date for admission under this category was 30.6.2014, 5.00.pm.

The candidates who get re-allotment/allotment will be issued with an allotment memo. First time admission candidates should pay the prescribed fee in the college to which allotted. The last date of joining will be 10.7.2014, 5.00.pm. As this is the last and final round of Counselling, any candidate who is allotted an MDS seat and fails to join on the stipulated date and time will have to pay the liquidated damages as per Clause XIII.2
