ORDER

The Hon'ble Kerala Administrative Tribunal, as per the order read above, has directed Government to consider and pass appropriate orders on Annexure A5 representation, before filling up the retirement vacancy of Dr. Krishna in Government Medical College, Thiruvananthapuram and issue appropriate orders by giving a posting to the applicant. In the Annexure A5 representation, the applicant has requested to consider her for posting against the upcoming vacancy of Professor in the Department of Pathology in Government Medical College, Thiruvananthapuram. The order has been complied with vide Government Order 2nd cited, by issuing direction to the Director of Medical Education to submit proposal for transferring the applicant to Government Medical College, Thiruvananthapuram as and when DPC select list is prepared for filling up the vacancy of Professor in the Department of Pathology, which may arise subsequent to the retirement of Dr.Krishna on 30.04.2021.

2. Meanwhile, Dr.Lailaraji.N, Professor of Pathology, Government Medical College, Kollam filed OA No.1006/2021 seeking a transfer to the vacant post of Professor in the Department of Pathology, Government Medical College, Thiruvananthapuram. The Hon'ble Kerala Administrative Tribunal, vide order dated 07.06.2021 had directed Government to consider the claim of the applicant for a transfer and posting against the existing vacancy, if any in the post of Professor in the Department of Pathology Government Medical College, Thiruvananthapuram. The order was complied with vide order read as 3rd paper above, by issuing direction to the Director of

Medical Education to consider the representations submitted by Dr. Lilarani Vijayaraghavan and Dr. Laila Raji N as per transfer norms and eligibility as and when DPC select list is prepared for filling up the vacant post of Professor in the Department of Pathology, Government Medical College, Thiruvananthapuram.

3. The Director of Medical Education as per the letter dated 08.06.2021 read as 3rd paper above, had submitted a transfer proposal in the post of Professor in the Department of Pathology wherein it was recommended to transfer Dr.Prema N.S, Professor, Government Medical College, Idukki to Government Medical College, Alappuzha, if Dr.Lilarani Vijayaraghavan is given a transfer to Government Medical College, Thiruvananthapuram and was proposed to fill the vacancy at Government Medical College, Idukki as and when the DPC select list is prepared.

4. Dr.Lilarani Vijayaraghavan has again filed OA No.1346/2021 and vide interim order dated 09.08.2021, the Tribunal had directed the Director of Medical Education to take a decision as to the eligibility of the applicant and the contesting claimant for a posting at Government Medical College Thiruvananthapuram on merits which decision shall be taken within a period of two weeks from the date of receipt of the order, without waiting for convening of the DPC. Accordingly, the Director of Medical Education as per the letter dated 25.08.2021 read as 3rd paper above, has submitted the proposal to Government.

5. As per the final order read as 5th paper above, the Hon'ble Tribunal directed Government to consider the claim of the applicant and the contesting claimant Dr. Lailaraji and to pass appropriate orders on their claim for transfer to Government Medical College, Thiruvananthapuram taking note of Annexure A4 order, Annexure A5 representation and the recommendation by the 2nd respondent on the request by Dr.Prema for transfer from Government Medical College, idukki against the vacancy that would arise at the Government T.D.Medical College, Alappuzha, without waiting for convening of the DPC, immediately, at any rate, within three weeks.

6. Government have examined the matter in detail and are pleased to issue orders as follows:-

- i. Dr.Lilarani Vijayaraghavan, Professor, Department of Pathology, Government Medical College, Alappuzha is transferred on compassionate ground with regard to the retirement date and posted in the existing vacancy of Professor in the Department of Pathology in Government Medical College, Thiruvananthapuram.
- ii. Dr.Prema N.S, Professor, Department of Pathology, Government Medical College, Idukki is transferred and posted in the vacancy of Professor in the Department of Pathology, Government Medical College, Alappuzha, which may arise subsequent to the transfer of Dr.Lilarani Vijayaraghavan.

7. The order dated 08.09.2021 of the Hon'ble Kerala Administrative Tribunal in OA No.1346/2021 is complied with accordingly.
