**ORDER**

The qualification and method of appointment to the post of Radiographer Grade-II under Medical Education Service was fixed as per the Government Order read as 2nd paper above. The Director of Medical Education, as per the letter read as 1st paper above, has submitted proposal for amending the qualification and method of appointment to the post of Radiographer Grade-II.

2. Government have examined the matter in detail in consultation with Kerala Public Service Commission and are pleased to amend the qualification and method of appointment to the post of Radiographer Grade-II under Medical Education Service as follows:

**I. Qualification**

1. Pass in Plus Two.
2. Pass in two year Diploma in Radiological Technology (DRT) conducted by the Directorate of Medical Education or its equivalent recognized by Government of Kerala.

**OR**

Pass in three year Diploma in Radiodiagnosis & Radio Therapy Technology (DRRT) conducted by the Directorate of Medical Education or its equivalent recognized by Government of Kerala.

**OR**

Pass in B.Sc. MRT degree or its equivalent from a recognized university and approved by Kerala State Paramedical Council and Atomic Regulatory Board.

3. Registration with Kerala Paramedical Council.

## **II. Method of appointment**

By direct recruitment through Kerala Public Service Commission.

## **III. Age Limit**

No person shall be eligible for appointment to the service by direct recruitment, if he/she has not completed 18 years of age or if he/she has completed 36 years of age on the first day of January of the year in which applications for appointment are invited with relaxation as provided to Scheduled Castes/Scheduled Tribes and Other Backward Community candidates in the General Rules.

## **IV. Probation**

Every person appointed to the post shall, from the date on which he/she joins duty, be on probation for a period of 2 years on duty within a continuous period of 3 years.

## **V. Reservation for appointment**

The rules regarding reservation of appointment contained in General Rules 14 to 17 in Part II of the Kerala State and Subordinate Service Rules, 1958 shall be applicable for appointment to the post.
