As per the GO read as 2nd paper above, Government have revised the annual fee for the Professional Degree/P.G Courses in Government Medical/Dental/Nursing Colleges under the Director of Medical Education in the State from the academic year 2023-24 onwards. In the letter read as 3rd paper above, the Director of Medical Education has furnished a proposal to revise the fees structure of Paramedical Courses, viz., Diploma in Radio Diagnosis& Radio Therapy Technology (DRRT) and Diploma in Respiratory Technology (D.Resp.T.) which are not included in the GO read as 2nd paper above.

2) Government has examined the existing fee structure for these paramedical courses in Government Medical/Pharmacy Colleges under Director of Medical Education and decided to revise the annual fee for the students admitted from 2023-24 academic year onwards as follows:-
