## **ORDER**

As per the letter read as 1<sup>st</sup> paper above, Government of India have approved Rs.13.81 crore under the Centrally Sponsored Scheme for Strengthening & Upgradation of State Government Medical Colleges for increase in PG Seats in Govt.Medical College Alappuzha, Ernakulam & Kannur in 60:40 ratio and have released Rs.2,07,00,000/- as central assistance for the implementation of the scheme. As per the letter read as 2<sup>nd</sup> paper above, the Director of Medical Education has requested to release the state share along with the Central share.

2) As per the G.O read as 3<sup>rd</sup> paper above, Government accorded Administrative Sanction for the project 'Strengthening and upgradation of state Medical Colleges for increase in PG seats - Phase-II" at Government Medical Colleges Kannur, Ernakulam and Alappuzha and released the central share of Rs.2,07,00,000/- (Rupees Two Crore Seven Lakh only) (Rs.1.52 crore under the Head of Account "2210-05-105-63" and Rs. 55 lakh under the H/A "2210-05-789/796") to the SNA

account of Director of Medical Education, Thiruvananthapuram. As per the G.O Read as 4<sup>th</sup> paper above an amount of Rs.138.02 lakhs has been additionally authorized to effect the release of corresponding state share for the above project.

- 3) Government have examined the matter in detail and are pleased to release an amount of Rs.138.02 Lakh (Rupees One Crore Thirty Eight Lakh Two Thousand only) from the HoA "2210-05-105-28 22/23/24", "2210-05-789 -98 (02)/97(02)/96 (02)" and "2210-05-796-98 (02)/97(02)/96(02)" to the SNA account (SNA Account Number 40581625513, SLS code KL 37) of Director of Medical Education, Thiruvananthapuram.
- 4) The Director of Medical Education will take timely steps to regularise this additional expenditure through Re appropriation of savings only within the Grant before the close of the current financial year.
