### ORDER

As per the Government Order read above, sanction has been accorded for the posting of various faculties from other Government Medical Colleges to Government Medical College, Konni on transfer and working arrangement basis in order to fulfill the requirements as per NMC norms for recognition of MBBS admission. Accordingly, Dr.Neetha Jose, Assistant Professor, Anaesthesiology Department, Government Medical College, Thiruvananthapuram was transferred to Government Medical College, Konni.

2.Subsequently, Dr.Neetha Jose, filed OA No.2255/2021 before the Hon'ble Kerala Administrative Tribunal, Thiruvananthapuram for staying the operation and implementation of G.O(Rt)No.2667/2021/H&FWD dated 27/11/2021. (Annexure A-3 ) The Hon'ble Administrative Tribunal as per the order read as 2nd paper above has directed as follows;

*"Therefore, the above Original Application is hereby allowed and Annexure-*

*A3 order to the extent it-ordered transfer of the applicant from the Government Medical College, Thiruvananthapuram, to the Government Medical, Konni is hereby set aside.It is made clear that the 1st respondent will be at liberty to pass fresh orders if any required,taking into consideration of the observations and directions contained herein above."*

3.Government have examined the matter in detail in view of the directions of Hon'ble Kerala Administrative Tribunal and are pleased to cancel the transfer of Dr.Neetha Jose, Assistant Professor, Anaesthesiology Department, Government Medical College Thiruvananthapuram to Government Medical College, Konni as per the Government Order read above with immediate effect.
