ORDER

As per the G.O read as 1st paper above, Government have accorded Administrative Sanction for development of Government Medical College, Kottayam at an estimated cost of Rs 564 crore. Of of this,Rs. 273.26 Crore has been set apart for the Surgical Block (Civil Works -Rs.194.29 Crores, Equipment and Furniture- Rs-68.28 Crores, Specialized E&M services 10.69 Crores). As per the proceedings read as 2nd paper above, KIIFB accorded Financial Sanction for an amount of Rs.142.05 crores for the civil construction.

2) As per the letter read as ^{4th} paper above, the Director of Medical Education has furnished a revised proposal for procurement of equipment's for the Surgical Block with the recommendations of the Technical Committee for KIIFB works. The Technical Committee as

per the report furnished as per letter read as 3rd paper above, has reported that the proposal for procurement of Medical equipment and furniture to surgical block in GMC, Kottayam was recommended for an amount of Rs.115,17,22,928/- excluding 18% GST and consultancy charges at 0.75%. Along with GST and consultancy charges, the total requirement for equipment comes to Rs. 137.10 Crore. The TC has also reported that the financial outlay for the surgical block as per the AS is for Rs.273.26 crores and the F.S accorded for the civil construction is Rs.142.05 crores. Accordingly together with the revised list of equipment along with consultancy charges and GST, the total value of work comes to Rs. 279.15 Crores(142.05 crore + 137.10 = 279.15) which exceeds the original AS by 5.89 crores. The Technical Committee recommended the same as the revised components are essential for the smooth functioning of the departments in the Surgical Block.

- 3) Government, having examined the matter in detail and assessed the requirements of the components for the smooth functioning of the departments in the Surgical Block, are pleased to accord revised administrative sanction for an amount of **Rs.279.15 crores (Rupees Two Hundred and Seventy Nine Crore and Fifteen Lakhs only)** (FS amount of Rs.142.05 crore + Equipment amount of Rs.137.10 crore = 279.15 crores) including GST and consultancy charge for the development of Surgical Block, Government Medical College, Kottayam.
- 4) The G.O read as 1st paper above stands modified to the above extent only.
