ORDER

As per the letter read as 1st paper above, Government of India has sanctioned an amount of Rs.1.6416 crore and Rs.1.8684 Crore respectively for the HR components of Trauma care facility at GMC Alappuzha and of the Burn units each at GMC Thiruvananthapuram and Kottayam. Accordingly, as per the letter read as 2nd paper above, the Director of Medical Education has requested to transfer credit the said amount along with the state share to the respective SNA account maintained by the DME.

2)Government, having examined the matter in detail and as per G.O read as 3rd paper above, an amount of Rs. 836.4 Lakh is additionally authorized for the release of central share and its corresponding state share towards HR components of Trauma care facility at Government Medical College Alappuzha and HR components of Burn units each at Government Medical College Thiruvananthapuram and Kottayam. as detailed below.

1. Assistance for Development of Trauma Care Unit Facilities in Govt.Hospitals Located on National Highways, Alappuzha - Rs.

213.6 lakhs (Including state share for an amount of Rs.49.44 lakhs under the HoA"2210-05-105-28-07" and central share for an amount of Rs.164.16 lakhs under the HoA"2210-05-105-63-07")

2. National Programme for Prevention and Management of Burns Injuries (NPPMBI), Thiruvananthapuram - **Rs.311.4 lakhs** (Including state share for an amount of Rs.124.56 lakhs under the HoA "2210-05-105-28-14" and central share for an amount of Rs.186.84 lakhs under the HoA "2210-05-105-63-14")
3. National Programme for Prevention and Management of Burns Injuries (NPPMBI), Medical College, Kottayam - **Rs.311.4 lakhs**(Including state share for an amount of Rs.124.56 lakhs under the HoA "2210-05-105-28-03" and central share for an amount of Rs.186.84 lakhs under the HoA "2210-05-105-63-03")

3) Accordingly, further sanction is hereby accorded for the following;

1. Release and transfer credit an amount of **Rs.2.736 crores** (Rupees Two crore Seventy Three Lakhs and Sixty Thousand only) (including state share for an amount of Rs.109.44 lakhs {*CFY BP of Rs. 60 Lakhs +Additional authorisation of Rs. 49.44 Lakhs under the HoA"2210-05-105-28-07"*} and central share for an amount of Rs.164.16 lakhs under the HoA"2210-05-105-63-07") to the SNA account No.40581629970 of DME for the HR components of Trauma care facility at GMC, Alappuzha.
2. Release and transfer credit an amount of Rs.3.114 crore (Rupees Three Crore Eleven Lakhs and Forty Thousand only) (Including state share for an amount of Rs.124.56 lakhs under the HoA "2210-05-105-28-14" and central share for an amount of Rs.186.84 lakhs under the HoA "2210-05-105-63-14") to the SNA account no.40581630805 of DME for the HR components of Burn units each at GMC, Thiruvananthapuram
3. Release and transfer credit an amount of Rs.3.114 crore (Rupees Three Crore Eleven Lakhs and Forty Thousand only) (including state share for an amount of Rs.124.56 lakhs under the HoA "2210-05-105-28-03" and central share for an amount of Rs.186.84 lakhs under the HoA "2210-05-105-63-03") to the SNA account no.40581630805 of DME for the HR components of Burn units each at GMC, Kottayam.

4) The Director of Medical shall follow the guidelines issued by Government of India vide letter read as 1st paper above.

5) The Director of Medical Education will take timely steps to regularise this additional expenditure through re-appropriation of savings within the Grants/ Supplementary Demands for Grants before the close of the current financial year.
