ORDER

In the Annual Plan Budget 2021-22, an amount of Rs.16.26 Lakh has been provided under the head of account '2210-05-105-45-17 MW (P)' for implementation of the Plan Scheme '**Dental College, Thrissur**'. As per the letter read above, the Director of Medical Education has submitted a proposal seeking Administrative Sanction for implementation of the Plan Scheme "Dental College, Thrissur" for an amount of Rs.16.25 L by meeting the expenditure from the provision under Head of Account '2210-05-105-45-17 MW (P)' in the current year's budget and also requested sanction for transfer crediting the fund to the implementing agencies ie. P.W.D in advance.

2. The Departmental Working Group for Health & Family Welfare Department convened by Additional Chief Secretary (Health) held on 26/08/2021 scrutinised the above Plan Scheme proposal submitted by the Director of Medical Education and approved the same as detailed in the minutes read above.

3. In pursuance of the decision of the Departmental Working Group, Administrative Sanction is accorded for a total amount of **Rs.16,25,000/- (Rupees Sixteen Lakh and Twenty Five Thousand Only)** for implementation of the minor works "Construction of vehicle parking shed, patient waiting area & extension of canteen in Govt. Dental College, Thrissur" by meeting the expenditure from the provision under the Head of Account '2210-05-105-45-17 MW (Plan)' in the current year's budget.

4. Sanction is also accorded to the Principal, Govt. Dental College, Thrissur for transfer

crediting the amount to the implementing agencies ie. PWD in advance.

5. All the Works shall be done in a transparent manner and in accordance with the estimate, prevailing norms and conditions. All purchases will be made in strict observance of Stores Purchase Rules.
