**ORDER**

The qualification and method of appointment to the post of Lab Assistant (Dialysis) under Medical Education Service was fixed as per the Government Order read as 1st paper above. The Director of Medical Education, as per the letters read as 2nd paper above, has submitted proposal for amending the qualification and method of appointment to the above post.

2. Government have examined the matter in consultation with Kerala Public Service Commission and are pleased to amend the qualification and method of appointment to the post of Lab assistant (dialysis) under Medical Education Service as follows:

**I. Qualification**

*1 . Diploma in Dialysis Technology/Post Graduate Diploma in Dialysis Technology from a recognized Medical College/Institution approved by Government of Kerala/Kerala Paramedical Council*

***OR***

*Bachelor Degree in Dialysis Technology from a recognized University*

***Experience*** : *A working experience of not less than two years in the dialysis Department of a medical college for Diploma in Dialysis Technology/Post Graduate Diploma in Dialysis Technology holders.*

*2. Kerala Para Medical Council registration*

**II. Method of appointment**

*By direct recruitment through Kerala Public Service commission*

### **III. Age limit**

*No person shall be eligible for appointment to the service by direct recruitment, if he/she has not completed 21 years of age or if he/she has completed 36 years of age on the first day of January of the year in which applications for appointment are invited with relaxation as provided to Scheduled Castes/ Scheduled Tribes and Other Backward Community candidates in the General Rules.*

### **IV. Probation**

*Every person appointed shall, from the date on which he/she joins duty, be on probation for a total period of 2 years on duty within a continuous period of 3 years.*

### **V. Reservation for appointment**

*The rules of reservation of appointment (General Rules 14 to 17) shall apply.*
