2. Government have examined the matter in detail in consultation with Kerala Public Service Commission and are pleased to fix the qualification and method of appointment to the post of Technical Officer under Medical Education Service as follows:-

Name of post : Technical Officer

I. Qualification for By promotion:

A) B.Tech/BE degree in Biomedical Engineering/ Applied Electronics and Instrumentation/ Electronics and Instrumentation/Electronics and Communication/ Electrical and Electronics from a recognized University.

B) A pass in Account Test for Executive Officers (KPSC)

Experience : Three years experience as Biomedical Engineer in Medical Colleges under MES

Qualification For Direct Recruitment

A) B.Tech/BE in Biomedical Engineering

OR

B.Sc Engineering Degree in Electronics

OR

B.Tech/BE Degree in Electrical & Electronics/ Electronics and Communication

OR

B.Tech/BE Degree in Applied Electronics and Instrumentation/Electronics and Instrumentation

Experience : 5 years experience in Biomedical Engineering in a recognized hospital with more than 300 bed with Super speciality Departments

II. Method of appointment :

By promotion of qualified hands from the category of Biomedical Engineer in MES.

In their absence,

By direct Recruitment

III. Age Limit

No person shall be eligible for appointment to the service by direct recruitment, if he/she has not completed 21 years of age or if he/she has completed 36 years of age on the first day of January of the year in which applications for appointment are invited with relaxation as provided to Scheduled Castes/Scheduled Tribes and Other Backward Community candidates in the General Rules.

IV. Probation

A pass in Account Test for Executive Officers (KPSC) for completing

probation. Every person appointed to the post shall, from the date on which he/she joins duty, be on probation for a period of 2 years on duty within a continuous period of 3 years.

V. Rules for reservation

The rules regarding reservation of appointment contained in General Rules 14 to 17 in Part II of the Kerala State and Subordinate Service Rules 1958 shall be applicable to appointment by Direct recruitment to the post.
