ORDER

As per Government Order read as paper 1st above, Administrative Sanction was accorded for an amount of Rs.3641.81 lakh for the project 'Construction of 200 bedded Cardiology Block at Government Medical College, Kottayam' under Tranche XXVI of NABARD RIDF scheme (NABARD share Rs.3095.96 lakh, State share 546.28 lakh). As per Government Order read as paper 2nd above, Government have entrusted M/s.HITES as the SPV for the project. As per Government Order read as paper 3rd above, Technical Sanction was issued for the above project for an amount of Rs.3025.66386 lakh.

Director of Medical Education as per letter read as 4th above, has submitted the proposal for the Reimbursement Claim of the cost of work done in February 2023, in respect of project Construction of 200 Bedded Cardiology Block at Government Medical College Kottayam (RAB 05) and has requested to reimburse the amount claimed for Rs.81.4782 lakh with necessary proforma.
