ORDER

The State Steering Committee on National Viral Hepatitis Control Programme (NVHCP) held on 24.08.2023 decided to include certain drugs and test kits in the Essential Drugs List (EDL) for the fiscal years 2024-25 and 2025-26 of Kerala Medical Services Corporation Limited. Accordingly, as per the letter read as 2nd paper above, the Director of Health Services furnished proposal to include the said drugs and test kits in the EDL for the fiscal years 2024-25 and 2025-26, thus enabling their procurement and distribution through the EDL tender system operated by Kerala Medical Services Corporation Limited (KMSCL).

2. Government have examined the proposal in detail and are pleased to accord sanction to include the following drugs and test kits in the Essential Drugs List (EDL) of KMSCL for the fiscal years 2024-25 and 2025-26;

1. Tab Entecavir 0.5 mg
2. Tab Entecavir 1 mg

3. Tab Tenofovir Disoproxil Fumarate (TDF) 300 mg
4. Tab Sofosbuvir 400 mg
5. Tab Daclatasvir 60 mg
6. Tab Daclatasvir 30 mg
7. Tab Sofosbuvir 400mg + Tab Vetpatasvir 100 mg (FDC)
8. Tab Ribavirin 200 mg
9. Hepatitis B immunoglobulin (HBIG)

1. Anti-HAV-IgM ELISA
2. Anti HAV IgM Rapid Test
3. HBsAg Rapid Test
4. HBsAg ELISA
5. HBc IgM (Hepatitis B Core) Antibody- ELISA
