ORDER

Government are pleased to grant permission to the Hospital Development Societies / Hospital Development Committees / Hospital Management Committees of all Government Hospitals under Health Department and Ayush Department to pay bonus not exceeding Rs.4,000/- (Rupees Four Thousand Only) for the Onam Festival of 2024 to its employees, including those who are appointed by the Committee and paying remuneration out of any other funds including KASP fund, drawing total remuneration up to and including Rs. 37,129/- (Rupees Thirty Seven Thousand One Hundred and twenty nine Only) as on 31.03.2024 as per G.O read second above.The Bonus as above will be admissible to such employees who have worked for at least 200 days since last Onam (ie. 2023). In all other cases an amount of Rs.2,750/- (Rupees Two Thousand Seven Hundred and Fifty Only) will be paid as Festival Allowance.

2. Payment of Bonus / Festival Allowance will be subject to availability of fund with the concerned Hospital Development Societies / Hospital Development Committees / Hospital Management Committees and paying remuneration out of any other funds,including KASP fund and expenditure in this regard will not count for the ceiling of establishment expenditure imposed in earlier orders.
