ORDER

As per the application and letter read as 2nd paper above, the Administrator, Christuraj Hospital, Thokkilangady, Kannur has requested No Objection Certificate for starting B.Sc. Nursing Degree Course in Christuraj College of Nursing, Thokkilangady, Kannur. The Director of Medical Education as per the letter read as 3rd paper above has recommended to start the college with an intake of 40 number of seats subject to the condition that inpatient strength of I:3 (student:patient) and Teacher student ratio of 1:10 should be maintained and the institution should stop the GNM course and also subject to the condition that all labs need to be fully equipped for the training of B.Sc nursing student.

2) In these circumstances, Government are pleased to issue No Objection Certificate to the Administrator, Christuraj Hospital, Thokkilangady, Kannur for starting B.Sc. Nursing Degree Course with intake of 40 students in Christuraj College of Nursing, Thokkilangady, Kannur subject to the condition that inpatient strength of I:3 (student:patient) and Teacher student ratio of 1:10 should be maintained, the institution should stop the GNM course, all labs need to be fully equipped for the training of B.Sc nursing student and approval of Nursing Council of India, Kerala State Nurses and Midwives Council and affiliation from the Kerala University of Health

Sciences should be obtained before starting the course. All the conditions stipulated in the Government order read as 1st paper above shall also be strictly followed before admitting students for B.Sc. Nursing Degree Course.


