Vide application read as 2<sup>nd</sup> paper above, Chairman, Valluvanad Hospital Complex Limited, Ottappalam has requested to grant No Objection Certificate for starting a new nursing college named as Valluvanad Institute of Nursing Science. The proposed college offers B.Sc Nursing Course and the requested annual intake capacity is 60 students. Director of Medical Education, after conducting inspection has reported vide letter read as 3<sup>rd</sup> paper above that physical and clinical facilities available for the institution are adequate for starting B.Sc Nursing Program with an annual intake capacity of 60 students.
