 - Rs.7,24,200/- (Rupees Seven Lakh Twenty Four Thousand and

- 3. As per the letter read above, the Director (i/c), ICCONS informed that the income from the hospital is only very meagre and is required for the incidental expenses and maintenance work and there has been an urgent deficit of funds to meet the salary of staff from July 2024 onwards. Hence Director (i/c), ICCONS has requested to release the balance Rs.197.86 lakh as the second installment of the non plan allocation for 2024-2025.
- 4. Government have examined the matter in detail and have decided to release a total amount of Rs.39,50,000/- (Rupees Thirty Nine Lakh and Fifty Thousand Only) under the head of account '2210-05-105-36' to ICCONS as 2nd installment of non plan fund and order as follows:
 - Sanction is accorded for the release of Rs.35,00,000/- (Rupees Thirty Five Lakh Only) under the head of account '2210-05-105-36-31(NP) Grant-in-Aid General Salary'.
 - Sanction is accorded for the release of Rs.4,50,000/- (Rupees Four Lakh and Fifty Thousand Only) under the head of account '2210-05-105-36-36 (NP) Grant-in-Aid General Non Salary'.
