ORDER

As per Government Order read as paper 1st above, Administrative Sanction is accorded for the implementation of the scheme "Assistance to Malabar Cancer Centre" at a total estimated cost of Rs.28,00,00,000/-, by meeting the expenditure from the provision of current year's budget under the Head of Account 2210-05-200-96-35 (P) (Rs.16,80,00,000) & 2210-05-200-96-36 (P) (Rs.11,20,00,000). As per Government Order read as paper 2nd above, an amount of Rs.8,55,25,709/- is released under the head of account 2210-05-200-96-35(P) for the procurement of TESLA MRI SCANNER and Accessories and DEXA SCAN. Also an amount of Rs.5,00,00,000/- is released to MCC vide Government Order read as paper 3rd above.

- **2.** As per the letter read above, Director, MCC has requested to release the balance amount of Rs.14,44,74,291/- from the balance amount of budget provision for the financial year 2023-24 under the head of account 2210-05-200-96(P).
- 3. Government have examined the matter in detail. Sanction is hereby accorded for releasing the amounts, Rs.1 Crore (Rupees One Crore Only) under the head of account '2210-05-200-96-35-Grants for the creation of Capital Assets' and Rs.1 Crore (Rupees One Crore

Only) under the head of account '2210-05-200-96-36-Grant-in-Aid - General - Non Salary' to MCC subject to the following terms and conditions of fund release.

- i. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)No.62/2018/Fin dated 16/4/2018.
- ii. The instructions in Circular No.84/2008/Fin dated 09/12/08, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms)No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
- iii. The Director, MCC shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.
- iv. If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
