ORDER

The Director, Centre for Professional and Advanced Studies, Arpookara, Gandhinagar, Kottayam as per the application Dated 30.12.2021 read as 2 nd paper above has requested to issue No Objection Certificate for starting B.Sc. Nursing Degree Course in CPAS Institute of Nursing Education, Kottarakkara. The Director of Medical Education, Thiruvananthapuram as per the letter read as 3 rd paper above has recommended the proposal since the institution was found feasible to start B.Sc Nursing program with an intake capacity of 40 seats for the Academic Year 2023-24.

2) Government have examined the matter in detail. It is observed that the institution has obtained permission to use the building of General Education Department for the purpose of starting the Nursing College. As this building is a 10,000 sq. ft. building (3 floors), there shal be adequate space for 2 years students at least. In addition there is a 2000+ sq. feet building with the institution.

- 3)Government have examined the matter in detail and are pleased to issue No Objection Certificate to CPAS Institute of Nursing Education, Kottarakkara for starting B.Sc Nursing Course from the Academic Year 2023-24 with an intake capacity of 40 students subject to the following conditions:
- i. Necessary repairs and maintenance work shall be ensured to make the building suitable for use as the Nursing College. Setting up of classrooms, labs, library etc. shall be done after maintenance work is completed.
- ii. There will be no immediate need to vacate the building for autistic children, although it may need to be done before final LOP is given for the college.
- iii. All the deficiencies pointed out in the inspection report of DME shall be rectified and the approval of the Indian Nursing Council, Kerala Nurses and Midwives Council & Kerala University of Health Sciences shall be obtained and the conditions in G.O.(P)No.64/2012/H&FWD dated 17.02.2012 shall strictly be full filled, before the commencement of the course.
