## **ORDER**

As per Government Order read as paper 1 st above, Administrative Sanction was accorded for an amount of Rs.3641.81 lakh for the project 'Construction of 200 bedded Cardiology Block at Government Medical College, Kottayam' under Tranche XXVI of NABARD RIDF scheme (NABARD share Rs.3095.56 lakh, State share 546.28 lakh). As per Government Order read as paper 2 nd above, M/s.HITES was entrusted as the SPV for the project. As per Government Order read as paper 3 rd above, Technical Sanction was issued for the above project for an amount of Rs.3025.66386 lakh.

2. The Director of Medical Education (DME) as per letter read as 5 <sup>th</sup> paper above submitted the Reimbursement Claim for the cost of work done in October 2023 (RAB 13), in respect of project Construction of 200 Bedded Cardiology Block at Government Medical College, Kottayam and requested to release the reimbursement claimed

(Rs.36,64,509/-). Concurrently, as per the letter read as paper 6 <sup>th</sup> above, DME has also submitted the Reimbursement Claim for the cost of work done in November 2023 (RAB 14), in respect of the same and requested to release the reimbursement claimed (Rs.81,81,343/-).

- 3. Government have examined the matter in detail and are pleased to release an amount of Rs.1,18,46,000/- (One Crore Eighteen Lakh and Forty Six Thousand only) to the Director of Medical Education on account of Reimbursement Claim of the cost of work done in October 2023 (RAB 13) and November 2023 (RAB 14) for the project 'Construction of 200 Bedded Cardiology Block at Government Medical College, Kottayam' assisted by NABARD under RIDF XXVI by debit to the head of account '4210-03-105-12(01)-PV Infrastructure Projects Under NABARD'. The amount for the purpose has been additionally authorized as per Government Order read as paper 7 th above.
- **4.** The Director of Medical Education shall take timely steps to regularize this additional expenditure through Re-appropriation of Savings within the Grant/Supplementary Demands for Grants before the close of the current financial year.
