ORDER

The Chairman Managing Trustee, KMCT Institute of Pharmaceutical Education & Research, Chathamangalam, Kozhikode submitted an application vide paper read as 2nd paper above for NOC to start Bachelor of Pharmacy (B Pharm) Course with requisite fee as stipulated in the GO read as 1st paper above. The Director of Medical Education after conducting an inspection furnished a report vide letter read as 3rd paper above and reported that the institution has adequate infrastructure and all other facilities to start the Bachelor of Pharmacy (B Pharm) Course.

2. The government have examined the matter in detail and are pleased to issue **NOC to KMCT Institute of Pharmaceutical Education & Research, Chathamangalam, Kozhikode to start the Bachelor of Pharmacy (B Pharm) Course with 60 seats** as per their request on the condition that :

- (a) The institution shall obtain affiliation with Kerala University of

Health Sciences, Thrissur and Pharmacy Council of India for the course.

(b) The institution shall fulfil all the basic infrastructural facilities, including the building, laboratory, equipment and teaching faculty as per norms and standards prescribed by the Kerala Paramedical Council for the course.

(c) The institution shall agree to the condition that 50% of the total seats will be filled up from the merit list prepared by the Director of Medical Education/Director, LBS Centre for Science and Technology/Commissioner for Entrance Examinations, and the fee for those seats will be on the rates fixed by the Admission Supervisory and Fee Regulatory Committee and notified by Government from time to time.

(d) The institution shall agree to the condition that 50% of the total seats shall be management seats, which shall be filled by the Management based on merit or eligibility criteria fixed by Kerala Pharmacy Council and Kerala University of Health Sciences, and fee fixed by the Admission Supervisory and Fee Regulatory Committee and notified by Government from time to time

(e) The institution shall execute an agreement with the Government on (c) and (d) above.

(f) On completion of (a) to (e), the institution shall report to Government, for consideration of the Letter of Permission, and the course will be started only after the issuance of the Letter of Permission from the Government.

(g) The institution shall furnish a Bank Guarantee of Rs. 10 lakh for the course after getting the Letter of Permission.

(h) This No Objection Certificate will be valid for a period of two years from the date of issuance of the order.
