Minutes of the meeting of the second meeting of Asset Maintenance Fund - State Level Committee - 2023-24 held on 01.12.2023

ORDER

As per the Government Order read as paper 1st above, Government have set up an "Asset Maintenance Fund Scheme, 2009" in view of the erstwhile Asset Renewal Fund, consequent to the declaration in the Budget Speech, 2009-10. The objective of the scheme is to maintain the existing assets of Government but not creation of Assets. Accordingly as per Government Order read as paper 2nd above a State Level Committee, under the chairmanship of the Additional Chief Secretary (Finance) was constituted for effective administration of the Fund.

2. As per reference read as paper 5th above the Director of Medical Education has forwarded detailed estimate prepared by the Assistant Executive Engineer, PWD (Special Buildings Sub Division), Alappuzha for carrying out urgently required maintenance works (providing trussed roofing) of Ladies Hostel Building at Government Nursing

College, Alappuzha and requested to accord Administrative Sanction for the same under Asset Maintenance Fund Scheme.

3. The State Level Committee on Asset Maintenance Fund, in its meeting held on 01.12.2023 approved the above works, as per the minutes read above.

4. In pursuance of the decision of State Level Committee on Asset Maintenance Fund, Administrative Sanction is hereby accorded for maintenance works (providing trussed roofing) of Ladies Hostel Building at Government Nursing College, Alappuzha for an amount of **Rs.42,54,000/- (Rupees Forty Two lakh and Fifty Four Thousand Only)**, by meeting the expenditure under the head of account '**2210-05-105-61-(Non-Plan)**' from the current Financial Year's budget provision, subject to the following conditions:

- a. The works shall be carried out through PWD represented by the concerned Executive Engineer, PWD (Buildings Division), Alappuzha who is designated as the implementing officer.
- b. The work shall be executed within a time period of six months.
- c. The expenditure will be limited to the amount sanctioned.
- d. The amount sanctioned shall be utilised only for renovation/maintenance of existing assets, as stipulated in the Government Order read as papers first to third read above and in Circular read as 4th paper above.
- e. All works shall be done in a transparent manner, tender and other stipulated formalities shall be followed wherever necessary with respect to civil works and purchase of equipment or articles.
- f. The progress of the work shall be monitored by the Director of Medical Education.
- g. The implementing officer shall furnish action taken report once in every three months to Government in the Finance (Planning B) Department through the Director of Medical Education.
- h. The utilisation certificate duly countersigned by the Head of the Department concerned after completion of the work shall be submitted to Government in the Finance (Planning-B) Department.
- i. The Director of Medical Education shall ensure that there would not be any duplication of receiving funds for the same purposes.
