### ORDER

Government have issued No Objection Certificate for enhancement of B.Sc. Nursing seats from 50 to 100 at Amala College of Nursing, Thrissur from the Academic Year 2022-23, as per Government Order read as 2<sup>nd</sup> paper above. Since the institution failed to admit students in the enhanced seats during the Academic Year 2022-23 the management had applied for revalidation of NOC for effecting the enhancement from 2023-24, in tune with the provisions contained in Government Order 1<sup>st</sup> paper cited. Accordingly, as per the Government Order referred as 4<sup>th</sup> paper above, NOC was revalidated for effecting the seat enhancement w.e.f. the Academic Year 2023-24.

2. Kerala Nurses and Midwives Council and Indian Nursing Council as per the letters read as 3<sup>rd</sup> and 5<sup>th</sup> paper above respectively

have approved the enhancement of seats from 50 to 90 for the Academic Year 2023-24. Kerala University of Health Sciences as per the order read as 6<sup>th</sup> paper above has granted provisional affiliation to the institution for the Academic Year 2023-24.

3. Subsequently, the Principal, Amala College of Nursing, Amala Nagar, Kottayam as per the application read as 7<sup>th</sup> paper above, has requested to issue Letter of Permission for B.Sc. Nursing Degree Course in Amala College of Nursing.

4. Government have examined the matter in detail and are pleased to issue Letter of Permission (LoP) to Amala College of Nursing, Amala Nagar, Thrissur for conducting B.Sc. Nursing Degree Course subject to the condition that all the conditions stipulated in the Government order read as 1<sup>st</sup> paper above shall strictly be followed.
