### ORDER

In budget estimates 2022-23, Rs.30.00 crore has been provided to e Health Kerala under the head of account 2210-01-001-88(P) and Administrative Sanction has been accorded for utilizing a total amount of **Rs.29,63,31,116/-** for implementing the e Health related activities vide Government Orders read as 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Papers above. Out of this, a total amount of Rs.19,17,27,345/- was released vide Government Orders read as paper 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> above.

2. Now Project Director (PD), e Health Kerala vide letter read as paper 9<sup>th</sup> above, informed that the balance fund available in the PSTSB account towards the end of financial year 2022-23 was Rs.1078.78 lakh, out of which Rs.1068.78 lakh has been resumed after retaining 10 lakh

in the account. PD, e Health reported that, of the resumed fund, Rs.730 lakh was to be utilized for the settlement of committed payments for institutions under DME. PD, e Health also informed that Proceedings for total amount of Rs.6,60,60,341/- is pending with e Health. Hence PD, e Health has requested to take necessary steps to release Rs.6,60,60,341/- from the resumed amount of Rs.1068.78 lakh in the PSTSB account No.799012700000936 of e Health during 2022-23.

3. Earlier, the Project Director, e Health, vide letter read as paper 7<sup>th</sup> above, had informed that the connectivity charges to BSNL for e Health institution after one year of roll out has to be paid by the DHS/DME. Since the fund for this purpose was not available with the DHS, PD, e Health had requested to accord permission to utilize Rs.4,11,59,384/- from balance fund available in financial year 2022-23, for meeting committed payment for institutions under DME, kept in the PSTSB account of e Health, so as to avoid disconnection and for the smooth functioning of e Health institutions uninterruptedly. Accordingly, sanction was accorded to release Rs.4,11,59,384/- under the h/a '2210-01-001-88 (P)', from the provision for the financial year 2023-24, vide Government Order read as paper 8<sup>th</sup> above. Since the amount Rs.6,60,60,341/- which is now requested for by the Project Director includes the amount of Rs.4,11,59,384/- already released, the balance amount eligible for release to e Health comes to Rs.2,49,00,957/- (6,60,60,341-4,11,59,384).

4. Government have examined the matter in detail and are pleased to release an amount of **Rs.2,49,00,957/- (Rupees Two Crore Forty nine Lakh Nine hundred and fifty seven Only)** from the current year's budget provision under the head of account '2210-01-001-88 (P)' for re-allocating the same to the PSTSB account of e Health, Kerala.
