Government, in consultation with Kerala Public Service Commission, are pleased to fix the following qualification and method of appointment to the post of Senior Scientific Assistant (Blood Bank) under Medical Education Service:-

Method of appointment

- (a) By promotion from the category of Scientific Assistant (Blood Bank) under Medical Education Service
- In the absence of qualified hands under (a),
- (b) By direct recruitment through Kerala Public Service Commission.

Qualification

By promotion1. Pass in Plus Two

2. B.Sc MLT from a recognized University

OR

Pass in Diploma in Medical Laboratory Technology from a recognized institution or college

OR

Diploma in Blood Banking Technology from a recognized institution

- 3. Registration with Kerala Paramedical Council
- 4. Minimum two years experience in the post of Scientific Assistant (Blood Bank)

By direct recruitment

- 1. M.Sc MLT (Pathology) from a recognized University
- 2. Registration with Kerala Paramedical Council

3. Five years experience in a licensed Blood Bank

Age limit

No person shall be eligible for appointment to the service by direct recruitment, if he/she has completed 45 years of age or if he/she has not completed 21 years of age on the first day of January of the year in which applications for appointment are invited with relaxation as provided to Scheduled Castes/Scheduled Tribes and Other Backward Community candidates in the General Rules. No age limit for appointment by promotion.

Probation

By promotion

Every person appointed shall, from the date on which he/she joins duty, be on probation for a total period of 6 months on duty within a continuous period of one year.

By direct appointment

Every person appointed shall, from the date on which he/she joins duty, be on probation for a total period of 2 years on duty within a continuous period of 3 years.

Reservation for appointment

The Rules of Reservation of appointment (General Rules 14 to 17) shall apply to appointments by Direct Recruitment.
