2) The Principals of Self Financing Colleges shall collect NRI fees as Rs.15,00,000/- (Rupees Fifteen Lakh only) per student. The collection of Rs.5,00,000/- (Rupees Five Lakh only) towards Corpus Fund from the NRI quota students shall be subject to the final order of Hon'ble Supreme Court in SLP(C)No(s) 9885-88/2020 filed by State of Kerala and connected cases against the Judgement dated 23/07/2020 of Hon'ble High Court of Kerala in WP(C) No.7771/2018.

3) The tuition fee, special fee and other eligible fees in respect of SC/ST/OEC students admitted for the course in 2022-23 will be sanctioned to the colleges by the Director of SC/ST Development Department at the rates fixed by the Fee

Regulatory Committee for Medical Education in Kerala.

4) The fee fixed by the Fee Regulatory Committee as detailed above shall be the fee for the entire five year course of 2022-23 batch. Any Change regarding ownership of management of the Institutions during the entire five year course will not affect the fee as fixed by the Fee Regulatory Committee mentioned above.
