### ORDER

As per the G.O read as 1<sup>st</sup> paper above, Government have accorded Administrative Sanction for or an amount of Rs.4450 lakhs (Rs.3115 lakhs for equipments and Rs.1335 lakhs for construction activities ) and for appointing M/s HLL Life Care Ltd. as consultant for the Development of Tertiary.Cancer Care Center at Government Medical College, Kozhikode. As per the G.O read as 2<sup>nd</sup> paper above, Government have accorded administrative sanction for an amount of Rs.25.03 crores for the purchase of items and for carrying out civil work for Tertiary cancer Center at Govt. Medical College, Kozhikbde, subject to the concurrence of Purchase Committee.

2) As per the letter read as 4<sup>th</sup> paper above, the DME has reported that out of the amount of Rs.2503 lakhs which was allotted in the first phase, Rs.9,19,42,340/- has been paid to the consultant and the remaining amount of Rs.15,83,57,660/- transferred to the Principal's TSB account. It has also informed that Government had withdrawn an

amount of Rs.7,53,48,052 from the TSB account. Out of this an amount of Rs. 1,50,00,000/- was returned from the HoA "2075-00-800-72 (02) (PV)" to the TSB account No.716011400000112 of the Principal, Government Medical College, Kozhikkod vide the G.O read as 3<sup>rd</sup> paper above. Out of the remaining amount of Rs.6,03,48,052/-, an amount of Rs.4,66,49,634/- is the balance amount of central share of the project. Accordingly, DME has requested to release an amount of Rs.4 crore out of the above said amount for the purchase of the CT Scan Simulator for Govt. Medical College, Kozhikode.

3) Government have examined the matter in detail and are pleased to accord sanction for the purchase of the CT Scan Simulator for Govt. Medical College, Kozhikode for an amount **Rs.4,00,00,000/-** (Rupees Four Crore only) by re allocating the amount from the Current Financial Year Budget provision under the H/A 4210-03-105-28 (P).
