### ORDER

The Principal, Vice dean – Academics, KIMSHEALTH has requested for NOC for restarting General Nursing and Midwifery Course in KIMS School of Nursing, Chempakamangalam, Thiruvananthapuram with an intake capacity of 50 students as per application read as 2<sup>nd</sup> paper above. As per inspection report read as 3<sup>rd</sup> paper above, the Registrar, Kerala Nurses and Midwives Council has recommended for granting NOC for starting General Nursing and Midwifery Course.

2) The Government, after having examined the matter in detail, are pleased to issue NOC for restarting General Nursing and Midwifery Course with an annual intake capacity of 50 students from the Academic Year 2023-24 in KIMS School of Nursing, Chempakamangalam, Thiruvananthapuram, subject to the following conditions:

- i. Two more teaching faculty are required to be appointed before the commencement of the Course in order to maintain teacher student ratio of 1:10.
- ii. Since the Laboratories and Library are shared, a separate time schedule for GNM students should be allotted . Equipments and articles in the laboratory and the books in library are adequate for the time being but shall be increased

proportionate to the strength of admission in the upcoming academic years.

iii. Required area to be constructed for the Hostel is 17500 sq. feet as per INC guidelines. Therefore, area of the Hostel shall be expanded by the time of starting of 2025-26 Academic Year batch, in order to meet the required area.

3) All the conditions in Government Order read as 1st paper above and all the Guidelines issued by the Government, Kerala Nurses and Midwives Council and the Indian Nursing Council shall strictly be followed before the commencement of the course.
