## **ORDER**

As per the Government Order read as 2nd paper above, Government have issued prospectus for admission to B.Sc. Nursing Course for the academic year 2022-23 and as per the Government Order read as 3rd, 4th, 5th, 6th, 7th and 12th papers above, sanction was accorded to the Director, LBS Centre for Science and Technology to take action for making allotment to the B.Sc. Nursing Course seats in various Nursing Colleges.

2) In the judgment read as 8th paper above the Hon'ble High Court has ordered as follows:-

- a. the competent Authority of the Government will immediately intimate the 1st respondent, including the petitioner in the Centralised Allotment Process for the Academic Year 2022-23; and this shall be done within seven days from the date of receipt of a copy of this judgment.
- b. on the 1st respondent obtaining the afore requisition from the competent Authority of the State, they will immediately include the petitioner in the list and allow them to make admissions for the Academic year 2022-23 without any impediment; however, subject to all other requirements being satisfied.
- 3) In the judgment read as 9th paper above the Hon'ble High Court has ordered as follows:-
- a) The 2nd respondent DME will immediately intimate the 4threspondent LBS Centre for Science and Technology, including the petitioner, for the centralized allotment process for the academic year 2022-2023; and this shall be done within a period of seven days from the date of receipt of a copy of this judgment.
- (b) On the 4th respondent obtaining the afore requisition from the 2ndrespondent DME, they will immediately include the petitioner in the list and allow them to make admissions for the academic year2022-23, without any impediment; however, subject to all other requirements being satisfied.
- (c) I make it clear that the obligation of the petitioner to make an application before the 'INC', as per Section 13 of the 'Act', has not been dealt with herein; and I record that they have made such an application as per Ext.P7 and leave it to the said Authority to take a decision thereon as per law.
- 4) Accordingly, the Registrar, Kerala University of Health Sciences and the Director of Medical Education as per the letters read as 10th and 11th papers above respectively have furnished a new list of colleges for making admission to the academic year 2022-23.
- 5) Government have examined the matter in detail on the basis of the information furnished in the letter read above and are pleased to accord sanction to the Director, LBS Centre for Science and Technology to take action for making allotment to the B.Sc. Nursing Course in the Government merit seats of Self Financing Colleges which got provisional affiliation from KUHS as follows:-

- 6) The above Nursing Colleges shall comply with all other conditions in the Government Order read as 1st paper above, before admitting students. The Director, LBS Centre and Director of Medical Education shall take further action, as directed by the Court, to include the above Nursing Colleges in the Centralised Allotment Process immediately. The direction of the Hon'ble High Court in the judgments read as 7th and 8th paper above is complied with accordingly.
- 7) Government orders read as 2nd, 3rd, 4th, 5th, 6th and 11th papers above are modified by including the above Nursing Colleges.
