ORDER

As per Government Order read as paper 1st above, Administrative Sanction was accorded for an amount of Rs.3641.81 Lakh for the project 'Construction of 200 bedded Cardiology Block at Government Medical College, Kottayam' under Tranche XXVI of NABARD RIDF scheme (NABARD share Rs.3095.96 Lakh, State share 546.28 Lakh). As per Government Order read as paper 2nd above, M/s.HITES was entrusted as the SPV for the project. As per Government Order read as paper 3rd above, Technical Sanction was issued for the above project for an amount of Rs.3025.66386 Lakh.

2. Director of Medical Education (DME) has now reported that as per the agreement executed between M/s.HITES and the Principal, Govt.Medical College, Kottayam, M/s.HITES is eligible for 50% of the consultancy charges after the receipt of Technical Sanction for the project. DME pointed out that since Consultancy fee is calculated as 5% of Technical Sanction amount (Rs.30,25,66,386/-) and hence M/s.HITES is eligible for an amount of Rs.89,25,708/- as consultancy fee including 18% of GST. Hence, DME has requested to sanction an

amount of Rs.89,25,708/- for effecting payment as Consultancy charges to M/s.HITES as per the agreement executed.

3. Government have examined the matter in detail and are pleased to release an amount of Rs.89,26,000/- (Rupees Eighty Nine lakh and Twenty Six Thousand only) additionally authorized as per G.O read as 6th paper above, as Consultancy fees to M/s.HITES towards the project 'Construction of Cardiology block in Government Medical College Kottayam' assisted by NABARD Under RIDF Tranche XXVI from the newly opened head of account '4210-03-105-12-(01) INFRASTRUCTURE PROJECTS UNDER NABARD'.

The Director of Medical Education shall take necessary steps to regularize this additional expenditure through Reappropriation of Savings within the Grant/Supplementary Demands for Grants before the close of the current financial year
