ORDER

As per the G.O read as 1st paper above, Government have constituted Search Committee for the appointment of Director in CCRC and later the same was modified as per the G.O read as 2nd paper above Accordingly, the Search Committee invited notification and conducted interview on 08.12.2022 for the same. Since suitable persons could not be find out, the Government have directed the Director, MCC to take necessary steps to publish notification for the appointment of the Director, CCRC by giving extensive advertisement in Government / Departmental websites and press media as well and to forward the copy of the same to Government for publishing same in the Government website. The Director MCC, the Convener of the Search Committee suggested to constitute an Expert Committee comprising of Director of Medical Education, Director of a major Cancer Centre in the country and Director of an Apex Cancer Centre in the State for framing the

qualifications and experience required for the Director CCRC.

2) Government have examined the matter in detail and are pleased to constitute a committee for examining and recommending qualifications and experience required for appointment to the post of Director CCRC, with the following members;
