ORDER

As per the G.O read as 1st paper above, administrative sanction was accorded for an amount of Rs.717.29 crore for the development of Government Medical College, Thiruvananthapuram with KIIFB assistance. As per the letter read as 2nd paper above, the Director of Medical Education has furnished a proposal for according permission to utilize the balance amount from the sanctioned amount of Rs. 717.29 Crores for the additional works in the Women and Child Block in SAT Hospital with an estimated cost of Rs.12.38 crore. The SAT work is being done with the funds from NRHM and the additional amount is needed for the completion of the same.

- 2) As per the letter read as 3rd paper above, KIIFB has agreed for utilizing the balance amount in the sanctioned amount of Rs.717.29 crores for meeting the estimated amount of Rs.12.38 crore for the completion of the additional works in the Women and Child block in SAT hospital, subject to the condition that the overall cost shall be limited to the Administrative Sanction already issued for the project.
- 3) Government have examined the matter in detail and are pleased to accord Administrative Sanction for an amount of Rs.12,38,01,371/-(Rupees Twelve Crore Thirty Eight Lakhs One Thousand Three Hundred and Seventy One only) for the additional works in the Women and Child Block in SAT Hospital by utilizing the balance amount from the sanctioned amount of Rs.717.29 crores. M/s HITES is

designated as the Special Purpose Vehicle for the project.
