As per the letter read above, Director (i/c), Institute for Communicative & Cognitive Neurosciences (ICCONS) has submitted Annual Plan Scheme proposal seeking Administrative Sanction for implementing the aforesaid scheme, by meeting the expenditure from the above head of account from the budget provision for the FY 2024-25.

- 2. The Department Working Group Meeting for Health & Family Welfare Department held on 11.06.2024 scrutinized the above plan scheme proposal submitted by the Director (i/c), ICCONS and approved specific components of the proposals as detailed in the minutes read above.

All the works shall be done in a transparent manner and in accordance with the prevailing norms and conditions.
- **6.** The Director of Health Services, Thiruvananthapuram shall draw the amount and release the same to the Director, Institute for Communicative & Cognitive Neurosciences and (ICCONS).
