ORDER

As per G.O read as 1st paper above, Government have set up Kerala Medical Services Corporation Limited for the procurement, storage and distribution of drugs, surgical items, medical equipment etc for public Health Care institutions under the Government. As per the letter read as 2nd paper above, KMSCL has been allowed to procure biomedical equipment on behalf of the Special Purpose Vehicles executing hospital projects with KIIFB assistance. As per the G.O read as 3rd paper above, the KMSCL has been designated as the Special Purpose Vehicle for the procurement of equipment for KIIFB works at MCH Konni, as the procurement through the SPV, ie, M/s HITES was delayed. In order to get around the inordinate delay in the procurement and other ancillary process, KMSCL, as per letter read as 4th paper above has requested to engage them as SPV for equipment procurement for the projects under Health and Family Welfare Department, so that the entire equipment procurement process is streamlined and executed well within the committed timelines.

2) Government have examined the matter in detail and are pleased to designate Kerala Medical Services Corporation Limited (KMSCL) as

the Special Purpose Vehicle for procurement of medical equipment and instruments for all projects under the Health and Family Welfare department, irrespective of the funding source.

3) MD KMSCL shall follow up with KIIFB to get appropriate percentage overheads to KMSCL for providing procurement services.
