ORDER

As per Government orders read as 1st, 2nd, and 3rd above detailed guidelines were issued for implementation of the projects with the Assistance of Kerala Infrastructure Investment fund Board (KIIFB). As per order read as 4th paper above M/s KITCO Limited has been designated as the Special Purpose Vehicle (SPV) for the project "Development of Medical College Kasargode, Additional Works through Kerala Infrastructure Investment Fund Board (KIIFB).

2) As per the G.O read as 5th paper above, Government has accorded administrative sanction for an amount of Rs.160.23 crores for the MEP Package of Hospital block and construction of Residential facilities of GMC, Kasargode. As per the letter read as 6th paper above, the Director of Medical Education has reported that the construction of GMC, Kasargode is being planned in a phase wise manner. The Civil works of the Hospital Block of the college was being done using NABARD funds under Tranche XX which ended on 30.06.2022 and hence the DME suggested for completing the civil works of the

Hospital Block using KIIFB fund and accordingly forwarded a proposal for revised A.S for an amount of Rs.160.23 crore by omitting some components and reducing the some other components in the original Administrative Sanction order.

3) Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for an amount of Rs.160,23,40,367/- for the development of Government Medical College, Kasargode as detailed below;
