ORDER

As per the G.O read as 1st paper above, Administrative Sanction was accorded for an amount of Rs. 717.29 crore for the development of Government Medical College, Thiruvananthpuram with KIIFB assistance. Out of this an amount of Rs.31.09 crore has been earmarked for the strengthening of Imageology Service in Radio Diagnosis Department. INKEL was designated as the SPV for the project.

2) As per the letter read as 3rd paper above, the Director of Medical Education has intimated that though INKEL is the implementing agency for the development of the master plan, other works related to the existing building is done through PWD and strengthening of Imageology Service is a maintenance work in the existing building. Accordingly DME has furnished a proposal for administrative sanction for an amount of Rs.24,36,290/- as per the estimate prepared by PWD for the strengthening of Imageology Services in Radio Diagnosis Department, out of the fund already sanctioned for the master Plan in respect of the development of Thiruvananthapuram

Medical College.

3) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the General Electronics Work - supply and installation of LAN,CCTV, EPABX, PA system and computers at Imageology, Radio Diagnosis Department in Government Medical College, Thiruvananthapuram with an estimated cost of Rs.24,36,290/- (Rupees Twenty Four Lakh Thirty Six Thousand Two Hundred and Ninety only) through Public Works Department out of the fund already allotted for the master plan in respect of the development of Government Medical College, Thiruvananthapuram.
